## Trinity Presbyterian School Raffle Official Rules Spring 2020 Drawing for 50% of one child's 2020-2021 tuition.

## DATES:

• The Tuition Raffle will begin on January 13, 2020. The prize drawing will be held on February 8, 2020 at True Blue Gala and Auction.

## **ELIGIBILITY:**

- Purchaser must be a legal resident of the United States.
- Purchaser must be nineteen (19) years of age or older to participate.
- All federal, state, and local laws and regulations apply.

## **ENTRY:**

- Tickets will be sold for \$100.00.
- Per IRS Publication 526, tickets are not tax deductible.
- The raffle ticket given at time of purchase will act as a receipt. Purchaser is not required to keep receipt to be entered into the drawing. Trinity Presbyterian School will store all raffle tickets until the time of the drawing.
- By purchasing a ticket, the purchaser enters this raffle and accepts and agrees to be bound by all the rules, regulations, limitations, and restrictions set forth herein.
- Upon purchasing of raffle ticket, the purchaser must designate the student who will receive the tuition credit should their ticket be drawn.
- A list of all participants will be kept at Trinity Presbyterian School and will be available to all entrants upon request.

## PRIZE:

- The name chosen on February 8, 2020 will win the grand prize of  $\frac{1}{2}$  tuition for the 2020 2021 school year.
  - This is a non-cash prize and will be posted as a credit to the student account.
  - The grand prize excludes registration, supplies, and other school-related fees.
- If the winner (name drawn) or beneficiary (family of child receiving the tuition credit) is on tuition assistance, the prize will be 50% of their tuition responsibility.
- If the winner (name drawn) or beneficiary (family of child receiving the tuition credit) is a Trinity Presbyterian School faculty or staff member, the prize amount will reflect the tuition discount given to Trinity Presbyterian School employees
- If fewer than 60 tickets are sold, the raffle becomes a 50-50 raffle.

- Ex: If twenty (20) tickets are sold, which raises \$1,000, the winner (name drawn) or their beneficiary (family of child receiving the tuition credit) will receive \$500 tuition credit, and Trinity Presbyterian School will receive \$500.
- To claim the prize, the student identified at time of ticket purchase must be registered for the 2020 2021 school year.
- All net proceeds benefit Trinity Presbyterian School.
- All prizes are subject to applicable taxes.
- The winnings are taxable per IRS guidelines.
- The winner (name drawn) and/or beneficiary (family of child receiving the tuition credit) are responsible for all federal, state, and local taxes.
- The winner must agree to meet with the accountant of Trinity Presbyterian School prior to the assignment of tuition credit to discuss all necessary details pertaining to the prize selected.
- Winner (name drawn) and/or beneficiary (family of child receiving the tuition credit) must sign and accept the contest rules before tuition credit will be assigned.
- Prizes are for the private use of the winner (name drawn) and may not be used for any other fundraising activity by the winner.

## WINNER SELECTION, NOTIFICATION, AND VERIFICATION:

- A ticket represents a chance to accept the stated prize subject to all terms and conditions set forth herein.
- The winning ticket shall be selected by a random drawing.
- The winner (name drawn) need not be present to win.
- The winner (name drawing) will be notified by a Trinity Presbyterian School agent and will have until the start of the next semester to accept the prize. In the event the winner (name drawn) fails to accept the prize within the time set forth or if the student subsequently withdraws from Trinity or is otherwise no longer a student, the prize shall be forfeited at the option of Trinity Presbyterian School, the prize will be forfeited and shall be contributed to Trinity Presbyterian School.

- The student to receive the tuition credit must be identified at the time of the signing and acceptance of the contest rules.
- The student who receives the tuition prize must be enrolled at Trinity Presbyterian School at the time of the prize drawing (February 8).
- Once assigned to a student, the tuition prize is non-transferrable.
